INTRODUCTION

South Coastal Counties Legal Services, Inc., with a grant from United Way of Greater Fall River, has created this pamphlet and a DVD, both entitled, *Grandparents Raising Grandchildren*. These are available to the increasing number of grandparents in Southeastern Massachusetts who are raising their children's children. They have been distributed to the local Councils on Aging who should have them available. These grandparents are changing their lives completely when they unselfishly assume the responsibility of their grandchildren.

We dedicate the DVD and pamphlet to these grandparents to

1. reassure them that they are not alone and there is help available;

2. educate them to the multiplicity of agencies and organizations in Southeastern Massachusetts that are available to them for information and help; and

3. assist them in accessing these agencies and organizations.

When making contact with the agencies and organizations listed in this pamphlet, be sure to ask if they provide any other services that might be helpful to you and your grandchildren. Also, ask if there are other agencies or organizations that could be of help.

LEGAL INFORMATION

This is a good place to start if you have questions regarding benefits to which you and your grandchild may be entitled or if you believe that you may need representation in courts. Low-income grandparents may have access to free legal services. Others may need to contact a private attorney who specializes in family law.

South Coastal Counties Legal Services (SCCLS) Offices:

The amount of assistance available for grandparents from Legal Services Programs varies depending on any number of circumstance—funding, staffing, office priorities, etc., so there is no guarantee that you can obtain representation on any particular issue. Nevertheless, a call to your local Legal Services Program is likely to provide some information, assistance, and direction.

MASSACHUSETTS DEPARTMENT OF CHILDREN AND FAMILIES (DCF) FORMERLY DEPARTMENT OF SOCIAL SERVICES (DSS)

DCF places children with grandparents or other family members when it has become necessary to take custody of the children because of abuse, neglect or family crisis that would put children at risk. If this is the situation, placing a child with grandparents is known as a "kinship" placement.

The grandparents are then entitled to financial assistance, health insurance and

other services from DCF regardless of the caretaker income. However, the children must be in the legal custody of DCF to receive this help, even while they are living with grandparents.

EDUCATION

Grandparents will want to know the status of their grandchild's education. Whether the child is changing schools or not, the first person to contact would be the guidance counselor at both the new school and the previous one. She should be a source of much help to you now and in the future.

If your grandchild has "special needs," it is even more important to contact the guidance counselor. If the child has an Individual Education Plan (IEP) because of his special needs, the guidance counselor should refer you to the Director of Special Needs in that school or school district.

Emergency Aid to Elderly, Disabled, and Children can be obtained at DTA.

<u>Food Stamps</u> may also be available to purchase food through an Electronic Benefit Transfer card, even if you are not eligible for direct cash grants

Other assistance is available:

<u>Mass Health</u> (medical assistance which is provided through the Division of Medical Assistance)

<u>Fuel Assistance</u> is direct payment of heating bills for eligible homeowners and renters through the Department of Housing and Community Development. (1-800-632-8175)

<u>Weatherization</u> is assistance which provides items/services to help make your home more energy efficient, through the Department of Housing and Community Development (1-800-632-8175)

<u>WIC Program (Women, Infants and</u> <u>Children Nutrition Program</u>) This nutritional program is primarily for eligible children under the age of five, pregnant and postpartum women. It offers checks for nutritional food items. Telephone: (1-800-WIC-1007)

SOCIAL SECURITY ADMINISTRATION (FEDERAL AGENCY)

Social Security has different programs with different eligibility for each program.

Social Security Retirement Income-Grandparent must be over 62 years and have worked the required number of quarters. They will receive a monthly income check and be eligible for Medicare if they are over 65 years.

Social Security Disability Income (SSDI)— A monthly check may be sent to a disabled individual or an approved relation of the individual. He may also be eligible for Medicare.

Supplemental Security Income (SSI)—A monthly check will be sent to qualified individuals who are age 65 or older or blind or disabled.

MASSACHUSETTS OFFICE OF ELDER AFFAIRS (EOEA)

EOEA is the state agency that offers many programs and services through the Area Agencies on Aging, municipal Councils on Aging and other agencies that serve senior citizens age sixty (60) and over. Eligibility for some services can be based on income and/or need.

One of the most important services for grandparents raising grandchildren

would be the Massachusetts Grandparent Resource Network. This program provides information on local support groups and other resources for grandparents (and other kin) who are raising grandchildren.

HOUSING

If appropriate and affordable housing is a problem for you when your grandchildren come into your custody or if you are already on housing assistance, you should immediately contact your local housing authority. Almost every city or town has a housing authority that would be known to your local officials.

If you cannot afford a larger home on the open market, there are options available for subsidized housing. There are qualification requirements. Waiting lists can be long, so the sooner you contact your housing authority, the sooner you will have adequate housing.
