


County-Wide Preliminary Data:

Type of Incident: 1/1/23 – 9/30/23






There were a total of 1,051 incidents (OD and At-Risk) recorded in Plymouth County between 1/1/23 and 9/30/23: 71 (7%) were fatal; 525 (50%) were nonfatal; and 453 (43%) were categorized as "at-risk" individuals.

Fatal Incident Monthly Trend








There was on average 7.9 fatal ODs per month, or 71 total, in the County between 1/1/23 and 9/30/23. This is a 20% decrease over the 2022 monthly average of 9.9 or 89 total, for the same time frame.

--2021 **--**2022 **--**2023




There was on average <u>58.3 non-fatal ODs per month, or 525 total</u>, in the County between 1/1/23 and 9/30/23. This is a <u>17% decrease</u> over the 2022 monthly average of 70.3 or 633 total, for the same time frame.

At-Risk Monthly Trend

There was on average 50.3 At-Risk entries per month, or 453 total, in the County between 1/1/23 and 9/30/23. This is a less than 1% increase over the 2022 monthly average of 50.1, or 451 total, for the same time frame. Of note, 52% (234) of the at-risk entries during this time frame are related to individuals with alcohol use disorder and 22% (100) are Re-Entry clients.

Incident vs. Resident Town: 1/1/23 – 9/30/23



26% Same Town 74% Different Town


Analyzing just the 596 overdose incidents, **433 (74%)** of the OD incidents between 1/1/23 and 9/30/23 occurred in same town that the person lived in. However, in **153 (26%)** of the incidents the person was from a different town than where the incident occurred.

Naloxone "Saves": 1/1/23 – 9/30/23


Thirty-seven percent (153) of these incidents involved Naloxone being administered by a 3rd party family/friend prior to first responders arriving.



Again, analyzing just the 596 overdose incidents, Naloxone was administered in **416 (70%)** of the reported OD incidents. **Ninety-four percent (391)** of these events were non-fatal, while **6% (25)** of these overdoses resulted in a fatality.

Follow-Up Visit Contacts: 1/1/23 – 9/30/23

- 794 attempted Followup Contacts
- 49% (392) were successful in having contact with either the individual who overdosed, a family/friend, or both.



Fifty-one percent (202) of the successful follow-up visits (392) resulted in contact with the individual that had overdosed or was referred, <u>40% (156)</u> resulted in contact with Family/Friends, and <u>9% (34)</u> resulted in contact with both the individual and family/friends.



Of the 236 successful contacts with the person that overdosed or was referred (Individual Only and Both): 74% (174) resulted in the individual accepting services from the outreach team; 16% (38) declined the offer of services; and 10% (24) of individuals were already seeking services.
